Mr. Kittle questioned whether this has to be reported separately from the regular audit. Ms. Schulz explained that it is a separate audit with a different scope. This is more of a performance audit and not a financial audit. She confirmed that this is the first year the performance audit was required by the state.

Mr. Knight stated that the term "in substantial compliance" implies that the City is not in compliance on something. Ms. Schulz stated that she is not aware that the City is not in compliance with any of the requirements of Act 51.

8. OLD BUSINESS

<u>8a. Motions – Adopt Resolution to Authorize Publication of Intent to Issue Special Assessment and Capital Improvement Bonds.</u>

Ms. Schulz explained that on May 8th, City Council approved a resolution declaring official intent to reimburse certain road and building improvements with potential bond proceeds. The next step to allow the City to move forward with these bond issues requires City Council approval of the proposed resolutions directing the City Clerk to publish the Notices of Intent to Issue Bonds. As required by Michigan law, the resolutions authorized publication of the intent to issue special assessment and capital improvement bonds and starts the forty-five day referendum period that must run before either series of the City bonds can be issued. She explained that the Notices of Intent set the maximum principal amounts of the bonds that can be issued for the describe projects. If adopted, each resolution will appoint Dickinson Wright as the City's bond counsel and PFM Financial Advisors as the City's municipal advisor specifically for these bond issues.

Eric McGlothlin, with Dickinson Wright, explained that a bond resolution would then be presented to the Council which will set the exact parameters of the bond sale to be held in the fall, with a late fall closing of the bonds.

In response to a question by Mr. Kittle, Mr. McGlothlin confirmed that by the time the bond resolution comes before the Council, an estimated sources and uses table will be presented which will layout the sources of the money; whether there are any premiums or discounts expected; how much will be spent on the special assessment projects and capital improvement projects, and the cost of issuance.

Mr. Kittle questioned if it was possible that a block of bonds could be available to local residents. Mr. McGlothlin stated that question should be deferred to the financial advisor because they are the ultimate purchaser of the bonds and are tasked with understanding the market.

Ms. Mitchell questioned how many consultants were considered to be the City's bond counsel. Mr. Tanghe explained that the City continued with the existing bond counsel.

Mr. Kittle explained that in this situation, the City has a pretty good cash balance in its fund balance. He gave an example; if he had money in the bank and wanted to put on an additional or major capital investment into his house, he would not necessarily want to deplete his cash, if funds could be borrowed at a low interest rate. This is no different, which is why he is supporting it.

Ms. Mitchell stated that she understands the analogy. If this was something that was adding an improvement or enhancing the value, she would be along the same lines of thought. She stated that she sees this as a maintenance issue, not a home improvement type issue.

9. NEW BUSINESS

9a. Motion - Approve 2017 RCOC Summer Maintenance Agreement

Mr. Brisson explained that this is an opportunity for the City to do street sweeping on County roads, such as Walton, Joslyn, Baldwin, and Brown Rd, three-times per year. He noted that the compensation amount will cover the City's operating cost. He noted that the City has been sweeping around the mall just before the holiday season for a few years. This is an opportunity to capture the revenue for street sweeping and expand it to other areas of the City to improve the appearance of our curbs and gutters.

Mr. Kittle commented that the curb on Five Points by the apartments could use cleaning. He stated that this is great collaboration with the County and he looks forward to the possibility of even more collaboration.

RESOLVED: To approve the City Manager, as Street Administrator, to accept on behalf of the City of Auburn Hills, the 2017 RCOC Summer Maintenance Agreement to provide Street Sweeping Services on Walton, Joslyn, Baldwin and parts of Brown Road for an annual compensation amount of \$ 6,649.50 payable by the RCOC to the City of Auburn Hills.

9b. Motion - Approve 2017 Storm Rehabilitation Program

Mr. Brisson explained that each year the DPW inspects and cleans catch basins in one-third of the City. The deficiencies are budgeted for and repairs are made in the following year. This is an opportunity to try new technology which is a polymer product that can be either spray applied to "glue" loose material in or if there are problems with the pavement sinking around the structure, it can be injected to lift the pavement.

Ms. Mitchell questioned the durability of this approach versus the traditional approach. Mr. Brisson explained that Farmington Hills has structures that were repaired using this product seven years ago and are still holding up great.

Mr. Kittle questioned if this could be used for crackseal on roads. Mr. Brisson confirmed that it can be used to secure around pipes, essentially wherever mud-jacking is used. It also could be used for leveling concrete or asphalt.

10. COMMENTS AND MOTIONS FROM COUNCIL

Mr. Knight

- On behalf of the Optimist Club, thanked the City for assisting in the car show fundraiser. The
 proceeds will go directly to the Will Rogers School in the form of projects or any other similar school
 in the Pontiac District.
- Noted the "Road Closed Ahead" sign on N. Squirrel Rd needs a sign attached to it clarifying that it is Pioneer Drive closed, not Squirrel Rd.
- Stated that in front of Al Deen's this morning, he saw three double bottoms drive by within two minutes. He expressed amazement at the number of trucks. It is a mad house down there, but he is not sure we can fix it as the trucks cannot use the bridge.
- Announced that the Boys and Girls Club is holding their annual golf outing on September 6th.
- Commented that someone told him that the Chrysler Administration Building would be torn down.
 He told them that he had not heard that only that they may move their executive offices someplace else.
- Commented that Orion Twp is proceeding with paving all five lanes of Brown Rd. He expressed appreciation that they are making that a good road on both sides.

Mr. Kittle

- Requested staff take a look at the curb flooding at Five Points.
- Requested staff take a look at the modular home on Joswick that is overgrown with weeds.
- Commented that the crowd at the Concert in the Park was well behaved, the band was good, and he encouraged people to attend.

- Requested an update on 3250 at the southwest corner downtown. Mr. Tanghe stated that they
 signed their final Brownfield paperwork about three weeks ago. The City was told development on
 the site would begin in July. Building permits have not yet been submitted.
- Relative to the truck traffic downtown, questioned when the bridge over Opdyke Rd would be fixed.
 Mr. Juidici explained that the Road Commission has a project planned on Opdyke Rd from Auburn to Perry in 2018. They are currently seeking funding to replace the bridge and want to do it in conjunction with that project.

In response to a question from Mayor McDaniel, Chief Olko stated that the City is not directing the truck traffic in this area. Many of the trucks are working on the M59 project to the east. When asked why they did not take Opdyke to M59, they stated that they could not cross that bridge.

Mayor McDaniel questioned if there were any ordinances or motor vehicle law that prohibit driving on the sidewalk and curb which is continually damaging the pathways. Chief Olko stated that staff can do some research.

Mr. Kittle suggested delaying improvements to downtown until this issue is resolved.

• Commented that over the weekend he was doing work with the Senior Home Assistance Repair Program (SHARP) and explained SHARP to one of the neighbors. He stated that, where he was doing the work, the senior stated that since she has been a senior, she has lived in seven different communities and by far, Auburn Hills ranks #1 with senior services. It made him very proud to be part of the City and it was great to hear that people recognize that we do take care of our seniors.

NOTICE IS HEREBY GIVEN, that the City of Auburn Hills, Michigan, intends to issue special assessment bonds in the principal amount of not to exceed \$3,000,000 for the purpose of defraying all or part of the cost of the acquisition and construction of road improvements to all or portions of certain roads within the City of Auburn Hills and any and all related appurtenances thereto, such roads being Pacific Drive, North Atlantic Boulevard, Continental Drive, and Deepwood Drive.

The bonds will bear interest from their date at a rate or rates to be determined upon the sale thereof but in no event to exceed such rates as may be permitted by law.

NOTICE IS HEREBY GIVEN that the City of Auburn Hills, Oakland County, Michigan, intends to issue capital improvement bonds in one or more series in the aggregate principal amount of not to exceed \$8,000,000 for the purpose of defraying all or part of the costs of (a) road improvements to major and local roads within the City of Auburn Hills and any and all related appurtenances and (b) improvements to City of Auburn Hills buildings and other facilities, including without limitation the replacement of one or more roofs, parking lots or portions thereof, and other City of Auburn Hills facilities, structures, and related appurtenances.

In the event that such a petition is filed, the bonds will not be issued unless and until the issuance thereof shall have been approved by the vote of a majority of the electors of the City of Auburn Hills qualified to vote and voting thereon at a general or special election.
